WHAT IS "PROFESSIONALISM"?

As Charles E. McCallum wrote in his thought-provoking article "Professionalism: It's no joke," attorneys are frequently the target of jests which portray them as greedy, self-centered, and deceitful.* Sadly, the media generally does little to dispel this misperception. Mr. McCallum urged attorneys to return to the professional ideals so clearly enunciated in the Professional Rules of Conduct, which emphasize the importance of ethical conduct and the "exercise of 'moral judgment' . . . The true professional is passionately committed to quality, passionately devoted to the interests of the client, and passionately devoted to the public interest and the administration of justice." Honesty and integrity are of vital importance; as Mr. McCallum notes, "[h]onesty and integrity go together with loyalty, reliability, fairness and compassion to make up 'character,' which is sometimes defined simply as moral excellence." Dedication to excellence is also crucial: "[h]owever many times a professional may have done a particular task, he will seek each time to do it better than before. . . . The phrases 'good enough' and 'this will do' are anathema to the professional." *<http://apps.americanbar.org/buslaw/blt/2007-01-02/mccallum.shtml>

On **Saturday, February 4th**, nearly 600 students from across North Carolina will be walking into courtrooms in Asheville, Charlotte, Durham, Fayetteville, Greenville, High Point, Raleigh, and Wilmington with a lump in their throats and butterflies in their stomachs. They will come, not because they are in trouble, but because they have been hard at work for months preparing both the prosecution and defense for *State of Arcadia v. Kinsley Williams*. This year will mark the 20th consecutive year that the North Carolina Advocates for Justice have helped to administer and support the only statewide mock trial competition for high school students. The program touches the lives of hundreds of students and family members each year, positively impacting their perception and understanding of our system of justice and the attorneys and judges who are a part of it. It takes *hundreds* of volunteers to make these competitions a success! We count on legal assistants, paralegals, and law students as *site volunteers* to help with the logistics of the competition day, and attorneys and judges to serve as *scoring jurors* and *presiding trial judges* for morning and afternoon trial rounds. CATCH A GLIMPSE OF THE FUTURE!

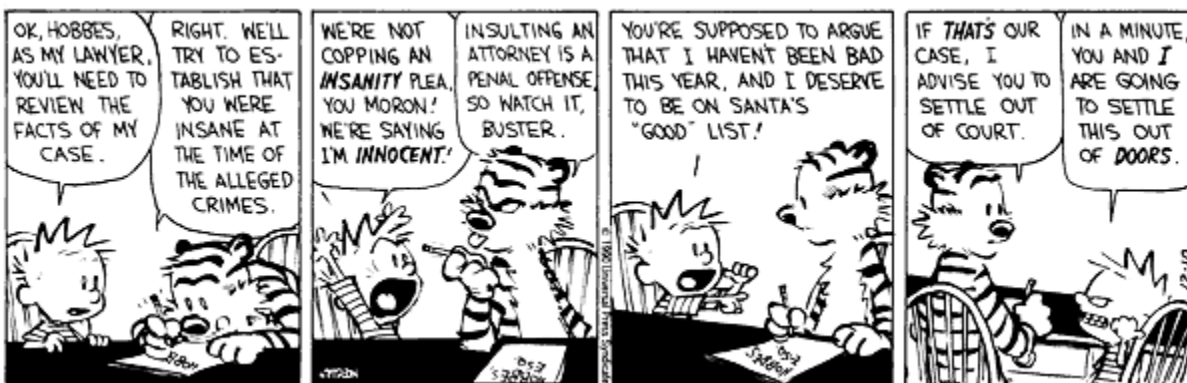
