<u>CAMPERS STRANDED OVERNIGHT; ONE STUDENT SERIOUSLY INJURED!</u>

June 25, 2014: Breaking News! 11 pm newscast transcript

Reporter Anna Folkrod here, with Utopia Eyewitness news in Eden, Utopia. We've just learned that twelve students at ForensiTech Camp right here in Eden appear to be missing tonight after going on a hike this evening. ForensiTech Camp is a forensics science camp holding its 5th annual summer session at Eden University. I spoke with ForensiTech Camp Director Hayden Woodward about the situation moments ago. Woodward refused to say anything other than that local sheriffs have been alerted and expect to find the students soon. A sudden, unpredicted rainstorm has apparently complicated their search efforts. Stay tuned for further updates.

June 26, 2014: 6 pm newscast transcript

Hello, this is reporter Robin Thomas with Utopia Eyewitness News. I'm here in Eden at the Garden County Medical Center, where I just spoke with ER physician Dr. Nicky Chintal. Dr. Chintal tells me that one of the stranded ForensiTech students, Justin Burke, was badly injured in a fall last night. Sheriffs did not locate the students until early this morning; the students spent the night on a nearby mountain, unable to find their way back to their van after hiking from a scenic overlook. Dr. Chintal would not provide any other details because Justin's parent, Sydney Burke, is flying back from a trip overseas and has not yet seen Justin. We hope to have more news on this disturbing event by tomorrow night.

June 27, 2014: 6 pm newscast transcript

Reporter Robin Thomas here, with another update on injured student Justin Burke, who reportedly fell while students were stranded overnight on a mountain near Eden. We've learned that Justin broke his neck and sustained a serious concussion during the fall; he remains in the ICU. Apparently Justin may have been suffering from low blood sugar on the hike due to Type I diabetes that was not disclosed to the camp staff. Both Camp Director Hayden Woodward and Justin's parent, Sydney Burke, are understandably distraught by Justin's injuries and pray for his full recovery. Neither wanted to talk with us on-camera; it appears this unfortunate accident may end up in our courts before it's all over.

Reporter "Robin Thomas" is correct; the case of *Justin Burke v. ForensiTech Camp, Inc.* will proceed to trial on **February 7, 2015.** Teams are already hard at work preparing the case, which was written by CCCE Program Coordinator Sue Johnson (author or co-author of our cases since 2012-13). In the process, students develop an appreciation for our trial-by-jury system; this year, they are also learning about Type I diabetes, spinal cord injuries, and wilderness first aid. A little over five years ago, Elizabeth Lail played the role of nuclear protester Pat Rodgers while competing in the North Carolina High School Mock Trial Competition. Later this week, she





takes her acting career to a new level when she stars in the ABC drama "Once Upon a Time."

Elizabeth started her high school career at Asheboro High School. For two years, Elizabeth was a member of the mock trial team coached by Steve Schmidly and Brooke Schmidly. During the 2008-2009 year, the case dealt with a nuclear war protestor suing a security guard for excessive use of force. On the plaintiff's side, Elizabeth used her acting talent to play the role of the plaintiff. On the defense side, Elizabeth was an attorney with an opening statement. Elizabeth's team won the Winston-Salem Regional, and then competed at the State Championship Tournament in Charlotte.

While in high school, Elizabeth displayed her acting skills not just in mock trial, but also in several school dramas. In 2009, Elizabeth was accepted into the highly selective acting program at the North Carolina School of the Arts. There, she graduated high school. She later received her Bachelor in Fine Arts from the School of the Arts in 2014.

Within months of her graduation, Elizabeth secured a role on the highly acclaimed ABC drama, "Once Upon a Time." The drama transports familiar Disney characters into the fictional town of Storybrooke, Maine, stripped of their memories. Elizabeth has been cast as "Frozen" character Anna.

The season premiere of "Once Upon a Time" will air on ABC on **Sunday, September 28** at 8:00 PM.
